Requests for Proposals (RFPs)

RFPs are official announcements that corporations, foundations, and government entities announce to make nonprofit professionals aware that these organizations have money to give through grant funding. RFPs also provide descriptions of the types of programs they support with grant funding, how to create the grant proposals, the amount of grant money available, and the submission process and deadlines.

The **Online Grant Writing MasterClass** teaches Grant Writers and other nonprofit professionals how to complete the time-consuming process of finding RFPs that match the vision of the 501(c)(3) nonprofit organization they serve. The class also walks you through the steps to apply for grant funding using RFP examples.
